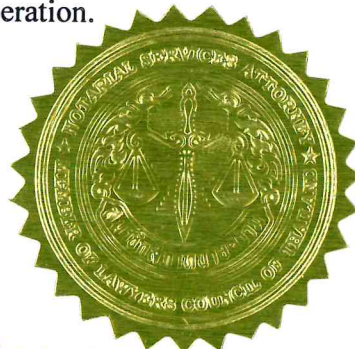
Dear all Sappe customers in the People's Republic of China (PRC),

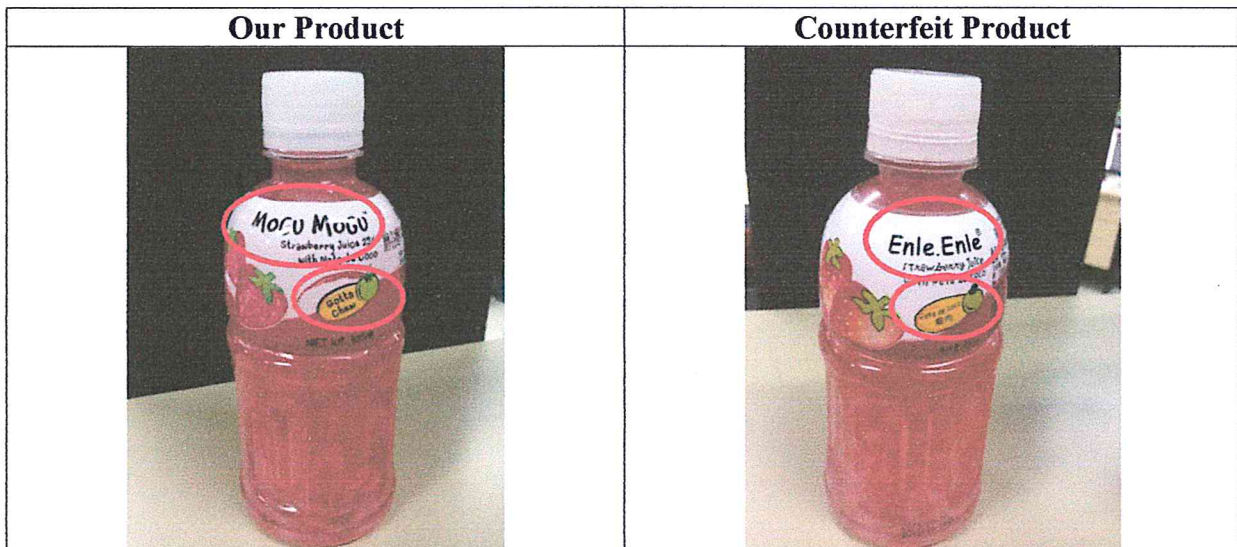

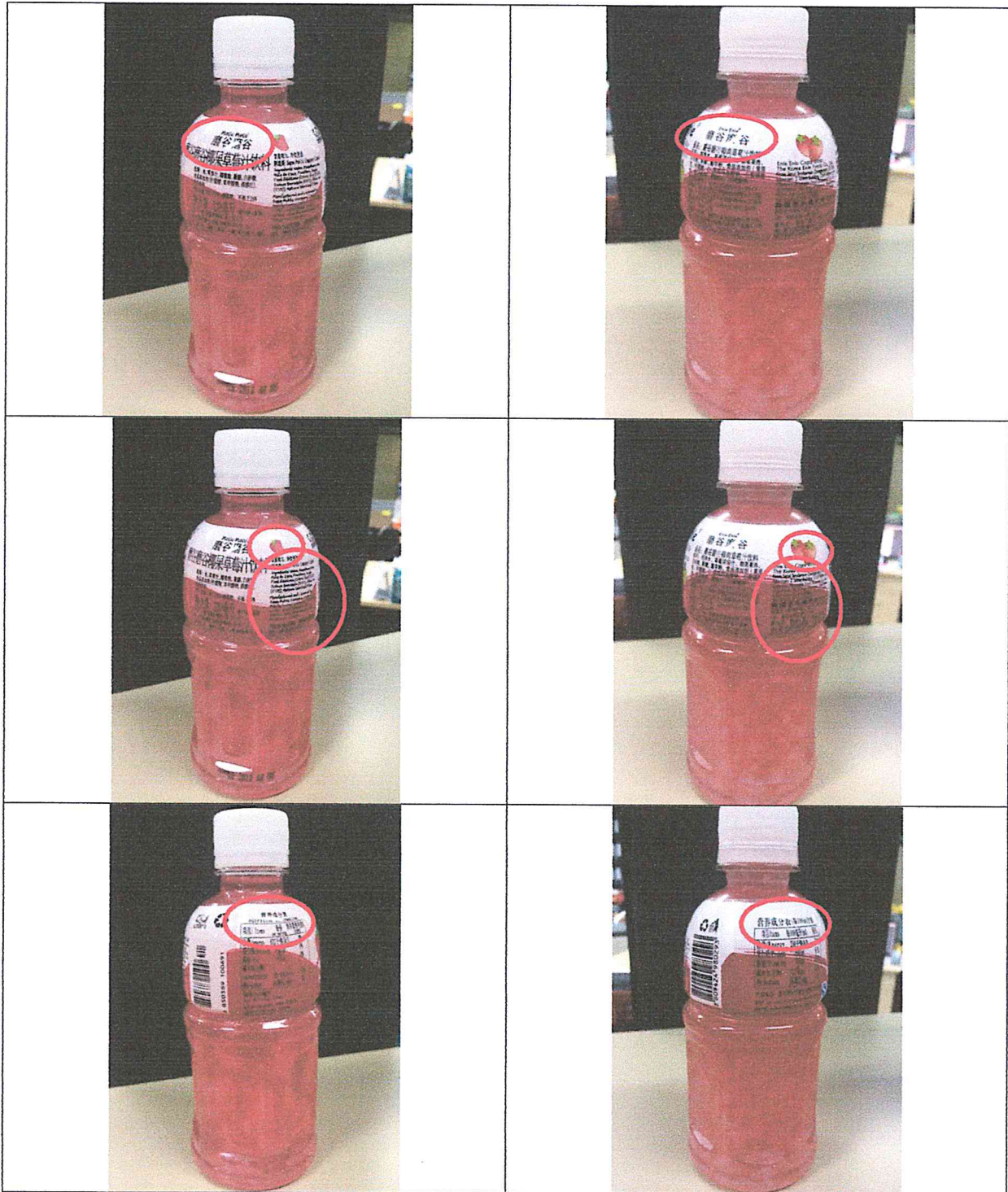
Dear all Sappe buyers in the People’s Republic of China (PRC),
